- RESOLVED:** That, at such time as the Dissolution Administrator determines the Nonprofit has satisfied its obligations under the Plan of Dissolution, the Dissolution Administrator shall execute the Articles of Dissolution and either file them or cause them to be filed with the Office of the Vermont Secretary of State.
- RESOLVED:** That this Unanimous Consent of Directors (the “Consent”) may be executed in two or more counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same instrument. Each director may execute this Consent by electronic or facsimile signature (including by affixing an electronic signature to the signature page through the use of secure digital encryption technology, such as DocuSign eSignature®, RightSignature®, etc.). PLAN OF DISSOLUTION

**Statement of Purpose.** This Plan of Dissolution (the “Plan”) describes the steps that will be taken if the Plan is approved by the Board of Directors (the “Board”) of Chill Global, Inc., a Vermont nonprofit corporation (the “Nonprofit”) to achieve a complete liquidation and dissolution of the Nonprofit in accordance with 11B V.S.A. §§ 14.01 *et seq.*, the bylaws of the Nonprofit, and the applicable provisions of the Internal Revenue Code and the U.S. Treasury Regulations related thereto.

1. **Cessation of Business.** The Nonprofit will cease to carry on business except to the extent necessary to wind up its business and affairs.
2. **Appointment of a Dissolution Administrator.** The Board shall nominate a person to oversee the dissolution process, who shall be known as the “Dissolution Administrator”. Such person may, but need not be, a director or officer of the Nonprofit. The Dissolution Administrator shall provide status reports to the Board throughout the dissolution process but may take any actions which the Dissolution Administrator in good faith determines are needed to dissolve the Nonprofit without further approval of the Board.
3. **Payment of Liabilities.** As soon as practicable, the Dissolution Administrator will take the steps necessary to have the Nonprofit pay all of its known current debts and liabilities.
4. **Notice to Creditors and Claimants.** The Dissolution Administrator will take the steps necessary to mail a written notice of the commencement of the proceedings for voluntary winding up of the Nonprofit to any known creditors and claimants whose addresses are contained in the Nonprofit’s records. Notices to known claimants must advise them of how and where to file a claim against the Nonprofit and advise them that they have a one hundred twenty (120)-day period in which to do so.
5. **Transfer and Distribution of Nonprofit Assets.** As soon as possible after the adoption of the Plan, the Nonprofit shall return, transfer, or convey any assets it holds subject to a condition requiring their return, transfer, or conveyance upon dissolution of the Nonprofit to the grantor(s) who provided the assets subject to those conditions. Then, the Nonprofit shall pay or satisfy all known debts and liabilities and distribute any remaining assets to the Nonprofit’s bank account to pay the claims of any creditors. If there are no such claims, the remaining assets will be distributed to Chill Foundation, a Nonprofit, a Vermont nonprofit which is exempt from taxation under Section 501(c)(3) of the Internal Revenue Code. None of the remaining assets will be distributed to benefit any of the directors of the Nonprofit, except if and to the extent of any salaries or compensation to be paid for their prior services to the Nonprofit. Legal title to any and all distributed assets should be changed to reflect the name of the recipient(s).
6. **Filing Articles of Dissolution.** Following the completion of all of the foregoing activities and any other dissolution-related activities which the Dissolution Administrator or the Board determine must be undertaken, the Secretary of the Nonprofit will execute and either file or direct another individual to execute and file Articles of Dissolution substantially in the form of those attached hereto as Exhibit A with the Office of the Secretary of State of Vermont.
7. **Tax Filings.** The Chair of the Board of the Nonprofit will timely file or cause another party to timely file any and all tax returns which the Nonprofit is required to file and any and all other state or federal forms, notices, documents and/or information required as a result of the Nonprofit’s dissolution and liquidation.
8. **Authorization of Necessary Acts.** The Nonprofit’s officers and directors will have the power and authority to adopt all resolutions, execute all documents, and take all other actions they deem necessary or desirable for the purpose of dissolving the Nonprofit and completely liquidating its business, assets, and affairs. However, nothing in this Plan will be construed to permit the officers, directors, or the Dissolution Administrator to take any action that would be inconsistent with the applicable provisions of the Internal Revenue Code or the Vermont Nonprofit Corporation Act, 11B V.S.A. §§ 1.01 *et seq.*

The Assignor hereby assigns, conveys, and transfers to the Assignee, all of the Assignor's right, duties, and obligations in and to all debts, obligations, and other liabilities of the Assignee, whether contractual, by matter of law, or otherwise (collectively, the "Liabilities").
